I know of (2) big floods in my adult life living in the Village. One in 1998 and one in 2003. Both caused large amounts of property damage that FEMA assisted in repairing but I have been unsuccessful in obtaining actual monetary figures and lists of items that were damaged. Normal flooding that we get annually doesn't cause damage to structures, but it has caused land in the affected areas to move quite a bit. The land in front of my former residence has shrunk considerably over the last several years. This issue could cause problem with State Route 145 in the village limits if not dealt with in a timely manner. If there is anything else needed, please email Jared and he can always email me and I can assist him if I have the information needed. Can you also forward this on to anyone else that might need to know that I am no longer handling the mayoral duties in the Village of Lower Salem?
