RSVP volunteers in collaboration with sponsors: Peoples Bank, Washington Electric Cooperative, The Marietta Times, The O'Neill Center, Washington State Community College, Mancan, Marietta City Schools, Promanco and Washington-Morgan Community Action all contributed to this years success.

A total of 726 coats were collected and 554 were distributed to local family's who needed them. The remainder of the coats were donated to the Samaritan House in Caldwell to be distrubuted through out the year.

#### The RSVP Tuesday Crafters have been very busy in 2011

Here is a glimpse of how the Tuesday Crafters spend their time and their generosity. Twenty bibs were given to the residents at The Inn in Marietta and approximately 36 were donated to the daycare at the O'Neill Center. Teddy bears were handmade and delivered to the Sheriff's department to be given to children who have been removed from their homes. Approximately 15 lap quilts were given to shut-ins in our area. Five quilts were donated to students at Ewing School to cover their wheelchairs as they come and go from their school buses. Washington County Home residents were the recipients of six lap robes. Table favors were made for the Senior Nutrition Program and the Meals on Wheels program during the months of February, March, April, July, September, November and December for a total of 1,708. Three quilts were made and donated to fundraisers for local organizations. Baby quilts were made and donated along with diapers for the Women's Care Center. Cancer caps were made and donated to cancer patients. Lap quilts, ditty bags, wheelchair bags, walker bags and bed-side caddies were delivered to the Veteran's Hospital. They were privileged to give one quilt to a recently wounded yet who lives in our area.

A member of the group also helps WASCO Seniors do monthly art projects and the Tuesday Crafters help them with supplies to do the crafts. Members also helped the VFW decorate plates with poppies to be distributed to the public. Several bake sales and craft shows to earn money for materials that are needed for projects were also done this year. The Tuesday Crafters invite you to come and join them!

# hello again... by Lisa Valentine, Director

The New Year is bringing new volunteer opportunities... great ways to make a difference in our community. Two programs set to start in March are Commodity Box Distribution and Senior Transportation.

The Commodity Box Program helps seniors stretch their groceries by providing a block of American cheese, a can of juice, four cans of vegetables, three cans of fruit, three cans of milk, two boxes of cereal, a package of pasta and either peanut butter, beans, or canned meat.

Volunteers are needed to distribute the boxes during a three day period at the end of each month. The Washington County Fairgrounds has donated office and warehouse space behind the Fair Board Office. Seniors enrolled in the program will drive up to the garage doors and volunteers will have them sign for their box of groceries. Some people may also need help loading the box into their car.

If this sounds like a volunteer activity that you might enjoy, please call me at the office. The current distribution window is two hours. If people don't pick up their box during the two hours the truck is parked at the fairgrounds, they miss out for the month. Extending the distribution time to cover three days will allow seniors more pickup options and ensure that they don't miss the monthly box of food.

We touched on the Senior Transportation program in the last newsletter. The funding has been approved and mileage reimbursement will be offered at the IRS rate of \$.55 per mile. Training will start in February. Don't let the unpredictable weather that February is famous for keep you from signing up. We will work around inclement weather to get everyone trained. The goal is to find one or two drivers from the following areas: Marietta, Beverly/Waterford, Lowell, Cutler, Belpre, Little Hocking and New Matamoras.

We will only be able to offer transportation services to seniors in areas we have an active driver, so please get the word out in your community for volunteer drivers. Drivers must be 55 years or older, possess a valid driver's license and good driving record. Call today for more information! We need you!

#### RSVP's - Ohio Benefit Bank News

Mid-November (16th, 17th, & 18th) was a busy time for RSVP's Ohio Benefit Bank Counselors. Penny Arsenault and Mary Emge, together with Sara Beaver, Benefits Counselor at the O'Neill Center, worked to enroll thirty-eight WASCO clients in the Golden Buckeye discount card program. This program connects Ohio's elderly and disabled residents to information about resources in their community and discounts on goods and services like prescription drugs, restaurant meals, and state park admission fees.

In addition, this enrollment project provided WASCO clients with the opportunity to practice general application process skills. WASCO Inc. is located off of Muskingum Drive in Marietta. WASCO is a non-profit organization which provides vocational opportunities and habilitation for people who have developmental disabilities.

# AARP tax aide available beginning February 1, 2012

The AARP Tax Aide program to help low and moderate income taxpayers will be available to Washington County and other area residents starting February 1st.

Three sites are available in Washington County. They are as follows: Barlow Branch Library site opens Wednesday, February 1st with hours from 10:00 a.m. to 3:00 p.m. and will be open each Wednesday through April 11th; the **Beverly Public Library** site opens Monday, February 6th from 10:00 a.m. to 2:00 p.m. and will be open each Monday through April 9th. The Marietta site at the Knights of Columbus building in Harmar opens Thursday, February 2nd from 9:30 a.m. to 4:00 p.m. and will be open each Monday and Thursday through April 12th.

Taxpayers are asked to bring photo ID, Social Security cards for themselves and any dependents, all W-2, 1099's, brokerage reports, last year's income tax report (if available) and itemized expenses (if you plan to itemize).

All of the volunteers are trained and certified by the IRS. The returns are prepared on computers and e-filed unless the situation requires paper filing. Taxpayers do not have to belong to AARP or be seniors to be helped. The service is entirely free.
