DRIVING DIRECTION TO PROJECT SITE:

READ THE FOLLOWING INSTRUCTIONS BEFORE COMPLETING THE REVERSE SIDE

1. In accordance with Ohio Revised Code (ORC) Section 3791.04 , before beginning the construction, erection or manufacture of any building for which construction documents are required, including all industrialized units, the owner shall submit THREE (3) copies of construction drawings to this department for approval.
2. THREE (3) bound sets of drawings, including plot plans, elevations, floor plans, and plans for elevator enclosures, must be submitted for approval. Drawings must be complete with wall sections showing footer, foundation, floor, wall and roof construction, indicating all structural members, size, spacing, material, etc. Two copies of the specifications for the work must be submitted, or the specifications may appear on the plans. The seal of an Ohio Registered architect or engineer shall be plainly visible in the lower right hand corner on all plans or drawings.
3. **ALL PLANS SUBMITTED SHALL PROVIDE SUFFICIENT INFORMATION AND DETAIL TO DETERMINE FULL COMPLIANCE WITH THE REQUIREMENTS OF THE OHIO BUILDING CODE (OBC).**
4. Our approval does not include zoning, sewage disposal or plumbing. Plumbing approvals for the City of Marietta are obtained through the City of Marietta Health Department, 304 Putnam Street, Marietta, OH, 45750, phone 740-373-0611. All other plumbing approvals are obtained through the Washington County Health Department, 342 Muskingum Drive, Marietta, OH, 45750, phone 740-374-2782. For plumbing approval in Belmont County, call 614-466-3543. Fire suppression submittals for projects in the Cumberland Trail Fire District must be submitted to that fire department 740-695-5147. City of Marietta zonings approval are obtained through the engineering department at 740-373-5495.
5. **COMPLETE ALL FOUR PAGES OF APPLICATION FOR PERMIT FOR EACH BUILDING OR STRUCTURE.**

A SEPARATE APPLICATION FOR CERTIFICATE OF PLAN APPROVAL SHALL BE SUBMITTED FOR EACH BUILDING OR STRUCTURE.

SECTIONS 303.02 TO 519.25 R.C. INCLUSIVE These Sections of the Revised Code provide for municipal, township, and county zoning. Many municipalities, townships, and counties have availed themselves of these provisions. Therefore, it is suggested that you contact the appropriate municipal, township, or county zoning before construction is begun.

SECTION 3791.04 R.C. (EXTRACTED AND PARAPHRASED) It is unlawful to enter into contract for or begin the construction of a new building/structure, the alteration of or addition to an existing building/structure, and /or changing the occupancy of an existing building/structure before receiving approved plans for the municipal or county certified building department. If there is no municipal or county certified building department, approved plans must be obtained from the Division of Industrial Compliance. Construction of the building/structure must be in accordance with the approved plans, and with the other provisions stated in Chapters 3781 and 3791 Revised Code.

Once the plans have been examined and approved, a Plan Approval (permit) will be issued to the owner or applicant along with two sets of construction documents. One of the sets of construction documents must remain at the job site at all times during construction. Inspections can be obtained from the Building Department by calling at least one day prior to needing an inspection at (740) 374-4185. Once all inspections have been obtained a final Certificate of Occupancy will be issued for occupied buildings.
